LEGAL AID SOCIETY OF CLEVELAND

Access to Justice: Leveraging Technology to Lower Barriers to Justice

The Legal Aid Society of Cleveland's Access to Justice Project set out to expand access to their services by adding an online intake module to their case management system. The implementation of this intake system provides 24/7 online access to the public, collaborating organizations and Cleveland Legal Aid's brief advice clinics with volunteer attorneys. By establishing three distinct ways in which online intake can be completed – independently online, through a partner organization's referral, and at a Legal Aid clinic, this grant expanded the capacity to provide underserved individuals with legal assistance.

When the coronavirus pandemic caused massive shutdowns and health crises nationally and globally, Cleveland Legal Aid was prepared to continue providing programs and services with no interruption. With 24/7 online intake capabilities, their client community could request help without risking their health and safety. Cleveland Legal Aid closed all four offices to the public on March 16, and all staff transitioned at that time to working from home. Attorneys kept in touch with clients via phone and email, and new clients utilized their new online intake portal to apply for free legal assistance. With this project, the online intake module was in place for months ahead of the COVID-19 pandemic and enabled Legal Aid to remain virtually "open" at clinics in Cuyahoga, Ashtabula, Geauga, Lake, and Lorain County.

One client helped during COVID-19 was Laurie Williams*. Laurie lives in private housing with her three sons and applied for Legal Aid's help online. To pay her monthly rent, Laurie uses cash assistance she gets from Ohio Works First, and her son helps cover the rest with his income from working for a food delivery service. Unfortunately, the son's income dipped dramatically due to the COVID-19 pandemic, and the family has been unable to pay rent.

Laurie reached out to Cleveland Legal Aid for help. An attorney helped Laurie apply for three months of rental assistance from EDEN, an agency that is administering funds set aside by the county for emergency rent relief. The attorney coordinated the gathering of necessary documents, helped Laurie complete her application, and spoke with Laurie's landlord, who agreed to accept the late rent and not evict her. Laurie's application was approved, and she was able to cover her rent for March, April, and May 2020.

FELLOW PROFILE

KERSTEN SJOBERG, DIRECTOR OF DISABILITY RIGHTS OHIO



When the 2020 Fellows class was initiated, it was the beginning of the pandemic and the class knew they had their work cut out for them. To accomplish the OSBF's mission to better the justice system, they were compelled to help the public and legal community navigate through the devastating effects of COVID-19. Meet Kerstin Sjoberg, one of several members leading her class' work.

Kerstin joined the OSBF because she wanted to deepen her connection to the legal community. Early in her career as a lawyer in private practice, she was very active with the Access to Justice committee of the OSBA and the pro bono committee of her local bar association. These experiences were professional learning and development opportunities for her and part of her path towards a full-time career in public service.

Being an OSBF Fellow is about giving back to the community through projects that increase access to justice and empower Ohioans to know and exercise their rights through education and helpful guides. It's also about working with other legal professionals on a shared goal and learning from each other along the way.

The class wanted to create helpful tools to alleviate the negative impact of the pandemic. This led to the creation of several quick hit videos on legal rights topics in areas that were impacted significantly by the pandemic, including changes in unemployment compensation and the rights of people with disabilities under restricted visitor policies at hospitals.
