Dear Judge Burnside,

As the new Director of Development and PR, I wanted to take a moment to introduce myself and, more importantly, thank you for your generous support of the Ohio State Bar Foundation.

I grew up on the West Coast and moved to Columbus in 2010 to do what I thought was a short-term assignment. I fell in love with the Midwest and decided to make Ohio my home. I joined the OSBF in July after spending two years as the Chief Marketing Officer for the Ohio State Bar Association. There I had the privilege of witnessing first-hand the tremendous impact lawyers can have on their communities.

To better understand my job, I began a deep dive into the Foundation's grant-making archives. As I researched the previous grants we have awarded past recipients, I discovered that your support of the Ohio State Bar Foundation has had far-reaching impact across Ohio.

■ Last year, the Ohio State Bar Foundation awarded almost \$1 million in grants. This included a 2019 grant where we awarded \$118,000 to the Ohio Center for Law-Related Education to fund their statewide programs, including Ohio Mock Trial, We the People and Moot Court. These programs provide high-quality civics and law-related content to teachers and students throughout Ohio.

Through support like yours, we granted \$65,000 to the Ohio State Legal Services Association to expand a youth law project, which provides advice, counsel and representation to young adults. The grant also expands training and advocacy for community providers and courts working with those transitioning out of foster care.

**All of this would not have happened without you. Your dollars made a big difference.**

I found other examples of the impact your support has had on organizations throughout the state:

- The grant to expand Veterans' Treatment Courts in every county and large municipality in the state.
- The grant to provide courses for prospective volunteer attorneys interested in providing pro bono assistance to underserved populations.
- The money awarded for skills-based training techniques designed to assist new lawyers in developing fundamental practice skills to become competent trial advocates.
